

ORDINANCE NO. 536

AN ORDINANCE CREATING CHAPTER 191 OF THE CODE OF THE BOROUGH OF DANVILLE ENTITLED SCHOOL ZONES AND ESTABLISHING A SCHOOL ZONE IN THE BOROUGH OF DANVILLE

WHEREAS, the Borough of Danville has received several requests that a School Zone be established for the Saint Joseph School in the interest of protecting the health, safety, and general welfare of the citizens of Danville Borough; and

WHEREAS, the School Zone area shall be defined as being at the five way intersection beginning at SR011, segment 0070, from Jacobs Alley to Pine Street, SR2010, segment 0010, from Ferry Street to Pine Street, and Ferry Street, 63' south of the crosswalk to Church Alley; and

WHEREAS, the Chief of Police and Council of the Borough of Danville have recommended the reduction of the Speed Limit to 15 mph in this designated school area from 7:00 a.m. to 8:00 a.m. and 2:30 p.m. to 3:15 p.m. on school days; and

WHEREAS, Chapter 191, Section 191-1 thru 191-5 is hereby created in its entirety with the following:

ARTICLE 1

Section 191-1 - School Zone area
Section 191-2 - School Zone speed limit
Section 191-3 - Violations and penalties
Section 191-4 - Enforcement
Section 191-5 Effective Date

ARTICLE 2

Section 191-1 – School Zone area
The area defined as the School zone shall be at the five way intersection beginning at SR011, segment 0070, from Jacobs Alley to Pine Street, SR2010, segment 0010, from Ferry Street to Pine Street, and Ferry Street, 63' south of the crosswalk to Church Alley.

Section 191-2 School Zone speed limit
There shall be a reduction of the Speed Limit to 15 mph in this designated school area from 7:00 a.m. to 8:00 a.m. and 2:30 p.m. to 3:15 p.m. on school days.

Section 191-3 Violations and penalties
Any person who shall violate any provisions of this chapter shall, upon conviction thereof, be punishable by a fine or not more than five hundred dollars (\$500) and costs

of such proceedings, or upon default of payment of such fines and costs, by imprisonment in the count jail for a term of not more than thirty (30) days.

Section 191-4 Enforcement

It shall be the duty of the Danville Borough Police Department to enforce the terms of this chapter and secure compliance with the requirement thereof.


ARTICLE 3

Section 191-5 Effective Date


Effective at such time as the proper signs have been erected, a "School Zone" shall be established at the five way intersection of SR 11, SR2010, and Ferry Street with reduced speed limit established at 15 miles per hour.
