

Resolution No. 2017-3

Resolution of the Danville Borough, Montour County, Pennsylvania, assigning or altering names of Borough Streets

WHEREAS, Montour County is consolidating 911 Center services with Columbia County; and

WHEREAS, most properties in Danville Borough will be readdressed based on the mapping system used by the 911 Center in Columbia County to ensure effective and efficient routing emergency responders to the location of the emergency; and

WHEREAS, properties will now be addressed with the street name on which the primary access is located; and

WHEREAS, several streets in the Borough of Danville are unnamed alleys or require alterations of the names to eliminate duplicate street names and ensure continuity in street naming across the Borough; and

WHEREAS, the Danville Borough Council is responsible for the naming of all streets and alleys owned by the Borough;

NOW THEREFORE, be it resolved by the Danville Borough and Borough Council, Montour County, Pennsylvania, shall assign the following street names and alterations:

- West Library Avenue: Arch Alley to Rooney Avenue, between W. Market Street and W. Mahoning Street
- Graham's Court: DL&W Avenue to Walnut Street, between Church Street and Forney's Court
- Forney's Court: DL&W Avenue to Walnut Street, between Graham's Court and DL&W Avenue
- James Court: Pine Street to Foust Street, between E. Front Street and Grand Street
- Cole's Alley: St. Joseph's School to Railroad Bed, between Blooms Street and Center Street
- Koocher's Court: Upper Susquehanna Levee to Foust Street, between Grand Street and Cooper Street
- Peter's Court: Cooper Street to E. Front Street between Nassau Street and Railroad Street
- Kelly Street: Montour Street to cul-de-sac at Beaver Place apartments
- Kriner Street: Beaver Place Street to Beaver Place Street around Beaver Place Housing
- Smith Street: Beaver Place Street to Kriner Street, between Kriner Street and Shelley Street
- Shelley Street: Beaver Place Street to Kriner Street, between Smith Street and Cook Street
- Cook Street: Beaver Place Street to Kriner Street, between Shelley Street and Kriner Street.
- DL&W Avenue: DL&W Street will be renamed DL&W Avenue for the entire length
- West Friendship Alley: Friendship Alley between Mill Street to Continental Blvd will be renamed West Friendship Alley
- Brosious Court: Cherry Street to Vine Street between Spruce Street and Little Ash Street
- Ironmen Lane: Liberty Street to State Hospital Drive, School entrance
- Beer's Court: DL&W Avenue to Walnut Street, between Ferry Street and Pine Street
- Leduce's Court: Before Liberty Street to State Street, between Wall Street and Fulton Street
- Industrial Court: Off Wall Street towards Sechler Run, in industrial area
