

MINUTES  
June 7, 2016

Danville Borough Council held a meeting on Tuesday, May 7, 2016, at the Borough Building, 239 Mill St., Danville at 6:00 PM. Vice-President Rogers presided.

Present were Councilpersons Rodman, Rogers, A'zary, VonBlohn, Wickham, Herritt, Walters, Mayor Swank and Junior Councilperson Ciucci. Also present were S. Berkey, E. Gill, B. Horne, J. Graham and Solicitor Robert Marks Sr. Absent was Richardson.

The invocation was given by Rick Vreeland followed with the Pledge of Allegiance to the Flag.

**Topics**

1. Request from Lisa Tulino to use ballroom at little or no cost for a bridal event. Council agreed to follow the current protocol and be fair. Motion to deny this request was made by Mr. Wickham, second by Mr. VonBlohn and a unanimous vote, Council denied this request.
2. Motion by Mr. Walters, second by Mr. Herritt and a unanimous vote, Council approved a request from Peter Fleming requesting road closures for the fireworks display on July 16<sup>th</sup> as part of the Danville Heritage Festivities.
3. The West Market St. block party would like to change their date from Sunday, June 12<sup>th</sup> to Monday, June 13<sup>th</sup>. Motion by Mr. Rodman, seconded by Mr. VonBlohn and a unanimous vote, Council approved this change.
4. Motion by Mr. VonBlohn, seconded by Mr. A'Zary and a unanimous vote, Council approved the Flood Mitigation Program Grant Application Resolution.

**Old Business**

The Fire Department will report on their efforts for the "rehab unit" at a later date. This project and the discovery of funding is still ongoing.


Mayor Swank commended the Memorial Day service and gave everyone that participated her appreciation.
