WHEREAS, Chapter 207 Solid Waste of the Code of The Borough of Danville sets forth the rules and regulations governing the Borough of Danville's mandatory recycling curbside program.

WHEREAS, Section 207-22 Fees for curbside recycling allows Borough Council to establish the amount of such annual residential recycling fee.

WHEREAS, the annual recycling fee will be subject to change from time to time.

WHEREAS, it is the consensus of Borough Council that the fee should at the very minimum cover the annual cost of such recycling services through a third party vendor


NOW, THEREFORE, be it resolved by the Borough Council of the Borough of Danville, that the annual residential recycling fee shall be set at \$22.00 per year beginning on January 1, 2021. All other provisions of Chapter 207 of the Code of the Borough of Danville shall remain unchanged.




